## Minutes of the Annual Meeting of the Parish Council held on Monday 11th May 2015

1. Election of chairman and vice chairman A Swift was nominated and following a vote, it was resolved that he would be chairman. A Lee was nominated and following a vote, it was resolved that A Lee would be vice-chairman.

# 2. Signing of Declaration of Acceptance of Office and agreement to abide by the Council's Code of Conduct by the chairman and councillors

The chairman and councillors signed a Declaration of Acceptance of Office form.
